## **Individual Study & Group Work**

The Executive Master in EU Studies allows students the opportunity to study both individually and together with peers and experts to exchange opinions and views.

During their two years of studies, our students experience group work in in various interactive learning formats, such as simulations, case studies and project planning.

#### During the eight in-person weekend workshops, our students:

- study and practise the different strategies of various actors in international relations;
- learn how to read and understand judgements of the Court of Justice of the EU;
- analyse various strategies of lobby groups;
- practise their presentation skills.

## **Simulations**

Our students put their theoretical knowledge into practice with simulations of two European institutions.

→ Weigh up priorities, analyse strategies, take action

At the end of the first year during the Brussels workshop, students take on the role of a Head of State to negotiate and reach a unanimous agreement in a simulation of a European Council summit.

→ Prepare legal memos, write legal writs, take the stand

Then, during the second-year Berlin workshop, students put on their black robes for a simulation of a case before the Court of Justice of the EU.

They also train their debating skills in a 'debating society' exercise to discuss a specific controversial motion.

## **Project Work**

At the start of the second year, students can opt for either 'Project Cycle Management and Logical Framework Approach' or 'Strategic Planning of Development Programmes'. They learn how to organise and manage their work in an autonomous way, with the support of our experts, and learn the different steps of project planning.

Defend your Master thesis or professional paper and celebrate the successful completion of your studies.







## **Degree and Recognition**

Graduates are awarded two certifications:

- **Executive Master in EU Studies** CIFE's diploma, certifying successful completion of the curriculum granting 60 ECTS credits at Master level.
- Chargé de mission en organisations européennes et internationales (Policy Officer in European and International Organisations). This professional certification is recognised by the French State as a degree at Master level (Level 7 European Qualification Framework).

## **Application Requirements and Tuition Fees**

A **Bachelor degree or equivalent** (three years of study at university level) and **English proficiency** are required to apply for our programme.

The **tuition fees** are € 5,500 per year, which covers academic guidance, a virtual campus, technical support as well as board and lodging during the weekend workshops.

A limited number of **scholarships** reducing the tuition fees are available.
